The scorebook bond will be refunded if the necessary paperwork for the issuance of a USCA scorebook or for certification of the foreign scorebook is received by the USCA office within ten days of the trial. Canadian participants may use their Canadian scorebooks, provided a photocopy of the scorebook (including identification page) is given to the trial secretary for submittal with the trial results.
